New Business

A. 2020 Summer Concert Series

A discussion was held regarding the cancellation of the 2020 Clio Amphitheater season due to the COVID-19 virus. Gary Langdon and Eric Wiederhold reported they have been in contact with all the performing acts scheduled for 2020 and they all appeared favorable to performing in 2021. If approved by the Clio City Commission, Gary Langdon and Eric Wiederhold will work to secure the performer contracts for the 2021 season.
